# Fishing Regulations

**KÄRNTEN**  
Naturpark  
Weissensee

By signing the fishing licence of the federal state of Carinthia the licensee accepts these regulations.

## & Dates 2026

**Fishing season: May 10 – November 20**

1a. Fishing is allowed only with valid annual fishing licence or fishing guest licence and permit. Persons, who have completed their 10th year of life but not yet their 14th, are allowed to fish only under survey of a person fully capable of acting. All licences are non-transferable.

**The fishing guest card is valid from 00.00 on day of issue until 24.00 on the last day of the validity period!**

1b. Basically, the regulations of the Carinthian legislation on fishery ([www.ktn.gv.at](http://www.ktn.gv.at)) apply.

1c. Every fish has to be recorded on the catch list.

1d. The regulations concerning the maintenance of a fish stock to be considered varied and appropriate to the habitat are supervised by the controlling body (§20, Abs.2)

### 2. It is compulsory:

- To observe close seasons and size limits. Undersized fish have to be carefully taken off the fishing rod with wet hands and released into the water.
- Not to release dead and evidently ill fish as well as dead lure fish.
- To illuminate the fishing place in order to keep it constantly visible during night fishing as well as not to let unattended the laid-out fishing rods. When fishing with floats they have to be kept visible by illumination too.
- To show fishing licence, equipment and caught fish to the fishing controlling bodies and to give the required information.
- Caught whitefish need to be kept in fishing boxes (coolers) right after the catch.
- If undersized fish are injured during capture to such an extent that they cannot be expected to survive, they shall be killed in a manner appropriate to the welfare of the animals and, after being cut up, shall be released into the water.

### 3. It is prohibited:

- a) To catch more than the maximum number of fish (see quantity / size limits / close seasons) per day.
- b) To fish apparently stocked trouts.
- c) To fish with more than 2 fishing rods (with one lure each).
- d) To fish from a motorized watercraft (it is forbidden to use electric motors, combustion engines and the like). **Electric motors need to be lifted!**  
Exemption clause: fishing from e-motorboats is allowed from September 15 to November 20!
- e) To use explosives, narcotic substances, firearms, hooks, harpoons, loops and electric fishing gears.
- f) To hook, drag, bounce, cull, as well as the use of artificial or chemical lights to attract aquatic animals.
- g) To use living vertebrates as lure as well as **self-brought lure fish**.
- h) To use fish innards as lure.
- i) To fish from the boat or other watercrafts (canoes, rafts...) from one hour after sunset until one hour before sunrise (night fishing).  
**Exceptional rule for the area west of Ronacherfelsen:** Night fishing from footbridges and other artificial installations is allowed. It is prohibited to use unsecured structures (natural shores) as fishing places during night fishing!  
**Exemption for the area east of Ronacherfelsen:** Fishing from a boat fixed on the shore is allowed in this area. The boat has to be illuminated and kept visible. The laid-out fishing rods have to be attended constantly. Floats have to be kept visible by illumination!
- j) It is not allowed to camp on the shores within the protected area.
- k) To fish in cultivation areas of water and cow lilies (plant conservation).
- l) To keep alive caught fish. Exemption: carps and tenches can be kept temporarily – max. 12 hours – during fishing in standard carp sacks.
- m) To fillet the fish on site.
- n) the use of Live-Scope technology

### 4. Please:

- a) Do not pour more than 3 litres of feeding stuff/day (impact on water quality).
- b) Do not fish from the landing stages and the bridge (penalization according to traffic regulations).
- c) Do not mark fishing places by buoys or other features.
- d) Regard the safety of bathers (risk of injury).
- e) Immediately inform Weissensee Information or the police about particular notices of all kind.
- f) Leave your fishing place clean.

Please mind that the lesser above mentioned regulations are observed, the stricter future regulations and punishments have to be remitted.

### **THERE IS NO ENTITLEMENT TO A REFUND OF FEES AND DEPOSIT ALREADY PAID!**

Please also consider those who will come after you, hoping to enjoy their hobby just like you.

### **Maximum amount/day, size limits and close seasons for fish and crabs:**

1 piece	Lake trout	70 cm	01/10 – 28/02
1 Stk.	Brown trout	70 cm	01/10 – 28/02
1 Stk.	Rainbow trout	70 cm	01/01 - 15/04
One trout may be taken per fishing permit per year. Exception for annual passes: 3 trout are allowed per year.			
3 Stk.	Arctic char	30 cm	01/10 – 28/02
3 Stk.	Pike-perch	50 cm	01/01 – 31/05
	Pike	keines	none
3 Stk.	Tench	25 cm	01/06 – 30/06
3 Stk.	Carp	45 cm	none

Maximum removal of 100 whitefish per year and angler.

Whitefish between 40 and 50 cm are to be put back without exception.

The deposit for this list of catches is € 15,-. Please hand this list over to one of the issuing offices or to your host right after expiry of the fishing licence. The refund of the deposit can happen only directly (**no mail or bank transfer**) and cash, until 20/11/2026 at the latest.

Please register every fish right after the catch to this list using a ball-pen specifying date, fish species, length and time.

Non-registration may result in suspension of the fishing licence.

The reissuing of the fishing licence can depend on this refund.

Non-observance of these regulations will result in suspension of the issued fishing licence and the list of catches.

There is no right to a refund of already paid rates and the deposit!
